WEDDING DAY LOGISTICS

On the wedding day, the hair will be done following a schedule. The Bride must communicate the importance of being on time and properly prepared. On location weddings, bridal party will be responsible for proper lighting and chairs. Stylist will bring full length mirrors and all hair and make up supplies. No shampoos will be given at on location sites. Every person getting their hair done in a formal style must have their hair already blown dry. The bride must confirm and commit to the number of services stated in this contract. Charges will include all people stated above.

FEE DETAILS

\$45 deposit is due to hold the date. Payment will go towards either trial formal style/make up. If you wish to do a trial for both there will be an additional \$45 due to your deposit total.

TRAVEL

Travel fees will be negotiated if the distance is greater than 15 miles outside of Grafton or St.

Louis. Parking fee will be added to bride's service total due at end of appointment.

TRIAL RUN

A trial is recommended for the Bride. This needs to be booked at least 4 weeks prior to the wedding day. Based on availability, the actual appointment can be up to 1 week before the wedding.

WEDDING DAY

The bride agrees to pay in full on the wedding date. The total amount due is based upon the wedding day services requested, parking fees and travel fees..
